HOW TO READ YOUR ELECTRIC BILL


Your Delaware Electric Cooperative bills will reflect the amount due for the electricity you use above what your solar produces each billing period. In billing periods where your solar produces more electricity than you consume, your bill may reflect a negative amount due (credit balance).

1

Your bill reflects the kilowatt hours (kWh) consumed above what your solar produced. Your bill does not show how much your actual solar produced.

Months where no usage appears in the graph means your solar produced more electricity than was consumed. That's great!

(Credit balances are not shown in the graph, but they get applied towards the next month's usage.)

This Usage figure reflects the electricity consumed above or below what your solar produced.

A negative Usage figure confirms your solar produced more electricity than was consumed.

If your electric bill shows you used 100 kWh during the billing period and your solar produced 800 kWh, then you used a total of 900 kWh of electricity. You will only be charged for the 100 kWh used from the utility company plus customer charges.
